## CHULA VISTA RESORT – CANINE AGREEMENT

Chula Vista Resort, Trademark Collection by Wyndham is a pet-friendly hotel that understands dogs are an extension of your family. We gladly welcome our guests traveling with their dogs. This agreement applies to domesticated dogs other than Service Animals. In consideration for the Hotel permitting me to keep my pet in my room assigned to me, I hereby agree to the following conditions:

- My pet is a domesticated dog that weighs no more than 50lbs. Two dogs are permitted to stay in one guest room.
- I agree to pay a non-refundable fee for my pet of \$40 per night, plus tax, per dog, per stay. I understand that additional fees may apply in the event that my pet causes any physical damage, or disrupts any other guest with noise during our stay.
- I agree to pay the Hotel any charges for any necessary cleaning or repair due to pet stains and/or damage, as determined within the sole discretion of the Hotel. I hereby authorize my credit card on file to be charged for the cost of those additional services, with my notice.
- I must keep my pet restrained, on a leash or in a pet carrier when my pet is outside my guestroom.
- I must notify the front desk and hang the “Pet Friendly Room” door hanger when I leave my pet unattended in my guestroom.
- I must properly remove and dispose of any litter or waste associated with my pet on Hotel premises. I understand that pets are not permitted in the waterparks, restaurants, spa, meeting facilities, golf course, or non-designated pet-friendly areas.
- I understand that I must be present in the guestroom with my pet if and while being serviced by anyone of the Resort Staff; this includes Housekeeping, Maintenance, Engineer, Guest Services, etc. If I am not in my guestroom at the time these services arrive, Resort Staff is instructed not to enter my room and perform these services.
- I agree that I am responsible for the noise my pet creates and will ensure that pet does not disrupt the quiet enjoyment of other guests. Should I, or my pet, be unable to control this noise, I may be asked to remove the pet from the property.
- I agree that should the Hotel determine in its sole discretion that my pet is objectionable to other hotel guests, I must immediately make other arrangements to house the pet outside of the Hotel.
- I agree to utilize pet relief areas located on property whenever possible – should my pet need relief outside these areas, I understand it is my responsibility to dispose of that waste.

I release the Hotel and Wyndham Hotel Group, its parent, subsidiaries and affiliates (the Hotel Entities) from any and all liability for any injury and/or injury suffered by my pet.

I agree and assume full responsibility for any injury and damage caused or alleged to be caused by my pet and incurred or alleged to be incurred by any guest, employee or invitee of the Hotel. I agree to indemnify, defend, hold harmless the Hotel from and against any and all alleged or actual losses, claims, damages, liabilities, costs and expenses (including attorney fees and court costs) suffered by the hotel or asserted by another hotel guests, invitee, employee or person arising out of, or in connection with, my pets stay at this Hotel. I understand and agree that the Hotel retains the right to exclude my pet if, in the Hotel's sole discretion, my pet is considered dangerous by reason of size, disposition or is likely to frighten or harm any other guests in the Hotel.
